This is a summary of the annual report for the THE RESOURCE CENTER HEALTHCARE PLAN, (Employer Identification No. 16-0968914, Plan No. 504) for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENTS

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of December 31, 2022 compared to \$0 as of January 1, 2022. During the plan year, the plan had total additions to net assets of \$5,077,403 and total deductions to net assets, including claims paid, of \$5,077,403.

Total plan benefit obligations at December 31, 2022 were \$360,858.

#### PAPERWORK REDUCTION ACT STATEMENT

According to the Paperwork Reduction Act of 1995 (Pub.
